Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

All new work and work of making good shall be carried out to match the existing adjacent work as closely as possible in materials and detailed execution.

Informative(s):

These works are to be carried out to the interior of the entrance building of Highgate West Cemetery. Dating from 1838-9 and designed by Stephen Geary the building is grade II listed. Originally the entrance of the West Cemetery consisted of an entrance arch flanked by an Anglican chapel and a Nonconformist chapel. The Anglican chapel has been restored while the Nonconformist chapel was converted to the cemetery offices in the mid 20th century.

The existing office layout is from the 20th century and in particular the glazed double height timber screen dates from 1989. The works hereby approved involve the following:

- a) Remove glazed screen at ground floor level. Modify support at first floor, and adapt moulding details to terminate principal mullions below ceiling level.
- b) Form glazed vision panel in fire door providing access to ground floor office.
- c) Form services duct in solid floor structure

The proposed works will be an enhancement to the historic building, they are not considered to harm significant historic fabric nor will they have a detrimental impact on the spatial character or appearance of the former Chapel.

Public consultation was not required in this instance as all the works are internal to a Grade II listed building.

The site's planning history has been taken into account when making this decision

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the National Planning Policy Framework.

- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 3 You are advised that any works of alterations or upgrading not included on the approved drawings which are required to satisfy Building Regulations or Fire Certification may require a further application for listed building consent.

You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays.
