Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

# Informative(s):

1 Reasons for granting listed building consent (delegated):

St Katherine's Precinct was constructed 1826-1828 to replace the religious hospice (of the same name) founded in 1148 adjacent to the Tower of London but cleared in 1825 to allow the construction of St Katherine's Dock. In an architectural acknowledgement of the original foundation the buildings were constructed in pseudo-gothic.

All the buildings within St Katherine's Precinct are listed Grade II\*. Works to refurbish the church and vicarage were granted previous conditioned consent (reference 2018/2185/L and 2018/2186/P amended 2019/0029/P).

Listed building consent condition 4 (part a) required detailed drawings, or samples of materials as appropriate, in respect of the new external handrails, including materials, finish and method of fixing.

The details submitted are considered acceptable in that they will preserve the special architectural and historic interest of the building. The site's planning history has been taken into account when making this decision.

Condition 4 (parts b, c, d and e) of 2020/2185/L have previously been discharged.

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the National Planning Policy Framework.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2019.
