We inspected this site and noted a very large Lime tree blocking out light/air to the surrounding properties.

FRONT garden

T1 = Large LIME –

Crown reduce height and lateral branches by 3-4m (regrowth) pruning back to leave selected shortened laterals near original pruning points. Thin canopy 25%. Remove 3 x limbs on property side back to framework (pictures attached). Remove trunk growth to main crown break.
