e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Large triple-stem Hornbeam - Thin throughout the crown by 10%

Reduce the crown spread on the east and west sides by 2.5-3m

The tenants/leaseholders feel that the tree is starting to encroach on the properties. The managing agents have been warned that the tree is showing signs of dieback in the upper crown on the north side; possibly due to root severance and/or ground compaction. We explained that a very delicate approach to tree pruning should be taken and no major overall crown reduction is recommended.
