The Council has considered your application and decided to grant approval of details.

Informatives:

- 1 Reasons for approving the details.

Details have been submitted to discharge conditions 8 (plant equipment) and 19 (PVs) of 2017/3933/P. In summary the details are acceptable and have been thoroughly reviewed by officers and internal specialist consultees (Environmental Health, Sustainability and Conservation).

Condition 8 - The proposals are acceptable in environmental health terms. The external plant is mostly within the approved plant enclosures and is acceptable by way of heritage and design.

Condition 19 - The PVs have maximised the sustainability output considering the sensitivity of the listed building with the Bloomsbury Conservation Area.

No objections were received prior to making this decision.

As such, the proposed details are in general accordance with policies CC5, A4, A1, G1, DM1, D1 and D2 of the Camden Local Plan 2017.
