T2- Sycamore rear left Smaller tree. To balance and contain spread suggest: reduce back to previous reduction points (approx. 2-3m)
T3 Lime rear left To improve light into garden and neighbouring property suggest: reduce back to previous reduction points (approx. 2-3m).
