Next door has submitted an application (5 Westwell , Plan No 1938-4-P-10) for a similar rear extension with a brick pier out to the end of my extension meaning the window on the angle will now look at a brick facing pier on the building line. This window is therefore removed and the other windows are redesigned to suit internal room use and layout. The front door has the side glass panel removed and becomes a security door. Building control has suggested a roof window over

the kitchen to provide additional internal light. This will protrude 360 mm with U value 1.2w/m 2 K and not be visible from the ground level from any direction. Separately whilst it is premature at this juncture and not the subject of this MNMA, if the Council is minded to approve the cladding on the adjacent planning application mentioned (grey window frames and western red cedar cladding), we would like to reserve the right to return to this process and make a further and separate Section 96A application for a minor change to our cladding as presently approved, which would be applied consistently over the whole frontage ground and upper level, probably a grained cream to compliment brickwork.
