Sycamore T1 (16M high, 400mm dia.) - Remove lowest branch over garage at rear of number 5, back to stem. Reduce crown of tree over the garden by up to 3 metres and balance remainder as necessary.

Sycamore T2 (15M high, 300mm dia.) - Reduce from side and roof of number 5 to give 2/3 metres clearance

Sycamore T3 (15M high, 300mm dia.) - Reduce from side and roof of number 5 to give 2/3 metres clearance
