The Council has considered your application and decided to grant Listed Building Consent subject to the following condition(s):

Conditions And Reasons:

1 The works hereby permitted shall be begun not later than the end of three years from the date of this consent.

Reason: In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

2 The development hereby permitted shall be carried out in accordance with the following approved plans:

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

3 All new work and work of making good shall be carried out to match the existing adjacent work as closely as possible in materials and detailed execution.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

The chimneys shall be reconstructed using the exsiting bricks and a lime based mortar with slightly recessed pointing. A sample panel of the brick work shall be constructed on site and approved by the Local Planning Autority prior to the works going ahead.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

Informative(s):

1 24 Heath Drive is a detached house constructed in 1907 and designed by Quennell. The buildings a large sweeping tiled roof with four tall chimneys. It is set over two floors with five windows to each floor.

Two of the chimneys on the south west elevation of the building have become unstable and have begun to lean. This is being further exacerbated by some of the renovation works that are taking place within the building.

An engineer has inspected the chimneys and has stated that the chimneys are beyond being braced and has recommended that they are taken down and rebuilt using the existing materials.

This approach ensures the longevity of the chimneys, securing their structural integrity and retaining both historic fabric and the architectural aesthetic.

The proposed works will not harm the special interest of the grade-II-listed building.

The application has been advertised in the press and by means of a site notice, whereby there were no consultation responses. The site's planning history has been taken into account in making this decision.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in general accordance with policy D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the NPPF.
