e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Silver Birch (T5) - Crown reduce by up to 30-35% & remove deadwood. To aim to stimulate juvenile regrowth, specimen currently very sparse and may have been affected by neighbouring foundation trench of greenhouse wall.
Hawthorn (T8) - Crown reduce by up to 30-35% & remove deadwood. To aim to stimulate juvenile regrowth, specimen has previously become over extended due to competition with vegetation that has subsequently been removed.
Apple (T10) - Crown reduce lateral spread of selective by up to 30% and deadwood,
Pear (T11) - Selectively Crown reduce general upper crown by up to 30-35% back to previous points of reduction, reduce back lateral spread on southwestern side of crown and taper in pruning to provide natural form to crown, remove deadwood. To aim to stimulate juvenile regrowth, tree has substantial growth lean but leaf flush is minimal/sparse and stressed, previously crown reduced.
Ash (T14) - TPO'd specimen, Crown reduce by 30-35% back to previous points of reduction, Reduce back vertical height of western scaffold trunks to 2m below previous points of reduction and taper in and shape resultant sub-lateral branches - Large horizontal open cavity at main fork, previously reduced specimen with tip heavy previous regrowth.
