DECISION

Town and Country Planning Act 1990

Certificate of Lawfulness (Proposed) Granted

Reason for the Decision:

1 The two rear roof dormers are permitted under Class B of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015.

Informative(s):

1 The development would only constitute permitted development if the materials used in any exterior work of the rear roof extensions subject to the grant of this certificate, shall be of similar appearance to those used in the construction of

the exterior of the existing dwelling house, in accordance with Condition B.2 of the Town & Country Planning (General Permitted Development) Order 2015.

- The development subject to the grant of this certificate, would only constitute permitted development where the edge of the enlargement closest to the eaves of the original roof shall, so far as practicable, be not less than 20 cm from the eaves of the original roof, in accordance with Condition B.2 of the Town & Country Planning (General Permitted Development) Order 2015
- You are advised that this certificate only applies to the proposed two rear roof dormers and not to the proposed projecting rooflight as shown on the hereby approved drawings, as this is subject to criteria in Class C of the Town & Country Planning (General Permitted Development) Order 2015.
