Pittosporum (T1) - reduce by 1-2m from the tips and trim sides by 1m and crown lift up to 2m from the pavement
Acer (T2) - reduce by 1-2m from the tips and crown clean and crown lift up to 2m from the pavement
Lime (T3) reduce back to old wounds approx 2-3m from the tips and crown thin by 15% wounds approx 3-4cm and remove epicormic growth
Acer (T4) reduce by 2m from the tips and remove wisteria from crown
