e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

This is a plum tree, damson variety, which is 20+ years old. It reaches roof height of the church building next door, about 10 metres high, and has a trunk girth of 62cm. It does not have a TPO but North Villas is in a Conservation Area.  
The tree is significantly angled, 20- 25 degrees, towards the Church Studio building. This is due partly to uneven top branch growth.  
Pressure from the trunk is causing severe cracking in the party wall. We are concerned that in this dry weather the party wall might collapse causing damage to the neighbouring small courtyard area and block the exit door from that Studios flat.  
We are requesting permission for the tree to be cut to below wall height so that we might pull the tree trunk back to upright growth. We have sought advice on this matter from the Cantelowes Tree Officer but as yet have had no email response.  
If that regrowth is not possible we have nurtured a self - seeded plum sapling in the centre of the garden which is now nearly 2 metres high which we will encourage to mature growth. We might be advised to replant this sapling in a container to limit its growth.
