Large copper beech tree on rear garden border between 50&52 Fellows Road. The tree is encroaching on my clients building causing issues with the guttering and tiles, it is also blocking out light to most of the windows on that side of the building. Proposed work: reduce back lateral growth towards 52 Fellows Road building and gardens by up to 3 metres (20%) and reduce major limb growing over into 52 Fellows Road garden by up to 4 metres (30%) to provide adequate clearance from building. The proposed works will not imbalance the crown as the tree is already heavily weighted towards 52 Fellows Road, proposed work will in fact balance the crown and will retain a tidy and uniform shape. All work will be carried out to BS3998 Standards.
