T1English Oak x 1 (Quercus robur) This large tree is starting to outgrow its location blocking light to the property.

Suggested works:

- Reduce overlong branches back into the main crown approx. 2-3m
- Clean out crown
- Remove substantial dead wood
- Remove epicormic growth

Front garden

T2Laburnum x 1 (Laburnum anagyroides) This tree is growing on to the wall with large included unions near the base with each stem displaying large fissures.

Suggested works:

- Fell to ground level by sectional take down

Front garden

T2Laburnum x 1 (Laburnum anagyroides) Grind down stump to approx. 300mm below ground level.

T3Holly x 1 (Ilex aquifolium) This tree is a poor specimen and is growing very close to the wall.

- Fell to ground level by sectional take down

T3Holly x 1 (Ilex aquifolium)Grind down stump to approx. 300mm below ground level.
