Proposed Work:  
FRONT GARDEN: 2 x Large Fir (T1) - Fell to ground level.  
1 x Cabbage Palm (T2) - Fell to ground level.  
2 x Large Fir (T3) - Prune both height and branch length by 50%.  
REAR GARDEN: 1 x Mimosa (T4) - Fell to ground level.  
1 x Large Palm (T5) - Fell to ground level.  
3 x Cabbage Palms (T6 & T7) - Fell to ground level.  
1 x Sycamore (T6) - Prune back branches by 33%  
1 x Large Fir (T8) - Prune back branches by 50%.  
1 x Large Elaeagnus (T9) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 02 June 2020 and does not wish to object.

- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
