T9 Yew- Crown reduce by 3m, prune back from lawn by 2m and prune back from neighbour's by 2-3m back to boundary line.
T17 Cypress- Reduce height by 3m and trim sides by 1-2m.
T21 Sycamore- Lift crown to 6m and prune to clear building by 3m.
