Species: Pyrus (Pear)

Position: Rear right hand side

Reason: Rose & Virgina invasion / Health & Safety / Dangerous

Fell above as close to ground level as reasonably practical, by sectional lopping / dismantling and roping down as necessary, to B.S.3998:21.3.

Species: Various

Position: Rear boundary and left hand side boundary

Reason: Overgrown / Shade nuisance

Trim top and inward facing side foliage only of rear boundary Hedera.

Cut Virginia back to fence line.

Cut all shrubs back to 10cm beyond patio wall.

Reduce Photinia down to a height of 2m.

Fell Bamboo as close to ground level as reasonably practical, by sectional lopping / dismantling and roping down as necessary, to B.S.3998:21.3.

Machine grind the above Bamboo stump(s) to 150mm below existing ground level, leaving chippings in situ, to B.S. 3998:21.3.1-2.

Cut back all neighbour's trespass back to fence line.

Reduce and shape Cotoneaster by approximately 50%, approximately 2-2.5m, cutting back to nearest suitable growing point.

Fell Fatsia as close to ground level as reasonably practical, by sectional lopping / dismantling and roping down as necessary, to B.S.3998:21.3.

Drill the cambium layer of Fatsia stump every 10cm around diameter and supply and insert to prevent regrowth, to B.S.3998:21.2 the following:

Ammonium Sulphate Stump Killer.
