 - Need details of the pipe runs of the fan coil units to be shown on drawings. If these are to be encased, please submit plan, elevation sections details at scale 1:20.
 - The works of alterations as shown on drawing no.481/022 Rev.F in particular the plant room area are unclear. Is a new partition to be installed in this area, if so please clarify with new drawings fully annotated.
 - Please provide a schedule of all works affecting the building fabric which are proposed to improve access for the disabled, including detailed section, elevations of the new handrails and their method of fixing.
 - φ Please provide existing and proposed door schedule including sections, elevations of all new doors at scale 1:10 (elevations) and 1:5 sections as well as method of upgrading existing doors.
 - Please provide elevation/section drawings of the proposed external condenser units showing in relationship to the boundary enclosure at scale 1:50.
