Rear garden adjacent to side of house.

Large mature tree in close proximity to property and overhanging neighbouring back gardens. To improve light into surrounding properties: Reduce canopy height by approx. 3-4m and lateral spread by 2m. (Crown reduce by 30%) Prune back from no.15 to provide adequate clearance from building (2m) Clean out crown, remove deadwood weak or suppressed branches. Retain inner canopy growth for crown continuity.
