We want to applaud the early consultation carried out by the applicant with the public and other local groups. And also the fact that that feedback was taken into account before submitting the application. If only more applicants did this, the planning system would work more efficiently and amicably.

This Forum is supportive of public houses as community assets and the proposed roof terrace would enhance this pub's offer to the public.

We are mindful of neighbours concerns about potential noise levels for neighbours. We were told that the application includes a terrace management statement which would minimise nuisance. The terrace will be closed at 10.30 pm, as agreed with residents groups, and anti social patrons exceeding noise or time limits will be removed from the premises. We trust that these taken together will remove any potential noise nuisance.

In design terms, the proposal to raise the balustrade by adding metalwork is, we believe, an appropriate solution for a Grade II Listed building. There is some confusion as to whether this will be cast or wrought iron – the drawings mentions cast but the documents say wrought. However, overall we think this is of little consequence, although cast iron would, we think, be more in keeping with the building's period style.
