T1 Eucalyptus rear Large, dominant tree for the surrounding area, reduced approx. 4-6 years ago (judging by its size of regrowth from previous pruning points). To contain lateral spread and improve light, suggest: reduce back to previous reduction points approx. 4m
T2 Willow front Leaning tree, pushing against and causing damage to front boundary wall pillar. Suggest: fell to ground level.
T3 Magnolia front To balance and contain spread: reduce and reshape by approx. 1m
