We have no objection to reasonable pruning and reduction (as long as this does not include pollarding) of the trees in the back or front gardens of 12 & 14 Maresfield gardens. However, we DO OBJECT to the felling of any of the trees: 1 x Purple Leaf Plum (Prunus cerasifera 'Nigra') (T2) - Fell to ground level by sectional take down, grind down stump to 300mm below ground level; 1 x Loquat (Eriobotrya japonica) (T6) - Fell to ground level, grind down stump to approx. 300mm below ground level. 1 x Cherry (Prunus spp) (T11) - Fell to ground level by sectional takedown. 2 x Holly (Ilex aquifolium) (T14) - Fell to ground level.
