Internal alterations. Relocate kitchen, relocate bathroom, provide additional en-suite bathroom, relocate entrance door.

The Council has considered your application and decided to grant Listed Building Consent subject to the following condition(s):

Conditions And Reasons:

- 1 The works hereby permitted shall be begun not later than the end of three years from the date of this consent.
 - Reason: In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
- The development hereby permitted shall be carried out in accordance with the following approved plans:

Site plan, 2001 P01A (exist plan), 2001 P05 (propo plan), 2001 P07 (exist services), 2001 P06 (en suite), design & access statement, statement of significance, heritage impact statement

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

3 All new work and work of making good shall be carried out to match the existing adjacent work as closely as possible in materials and detailed execution.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

Informative(s):

1 The site is the first floor of a grade-II-listed detached house of 1879. There has been a degree of internal modification, including the repositioning of the stairs, when the house was converted to flats in the 1960s.

The applicant would like to reorder the spaces, including swapping the positions of the existing kitchen and bathroom, and installing an en suite bathroom in the bedroom.

It has been shown that the existing service routes are adequate for the proposals. The new bathroom to the front of the house will drain through an existing riser. The en suite will be plumbed into an external SVP. In bedroom one, a large fitted cupboard and fire lobby will be removed and replaced with a cabinet of similar area containing the bathroom. The cabinet will read as a fitted cupboard and will be 90cm from the ceiling, so as not to harm plan form. Ventilation will occur through a discreet iron grille. All historic features will be retained and repaired where damaged.

Any works other than those specifically mentioned in the consented documents are unauthorised. If further works are found to be needed, the permission of the council's conservation team must be obtained in writing, or further listed building consent may be required.

The proposed works will not harm the special interest of the grade-II-listed building.

The site's planning history has been taken into account in making this decision.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in general accordance with policy D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the NPPF.
