T3 Laurel: Trim to tidy by approx 0.5m - routine maintenance

T4 Corkscrew Willow: Reduce by up to 3m (please advise if more is allowed). Tree is currently leaning (see photos attached) and this has happened previously. Client wants to keep tree but wishes to reduce as much as possible to maintain. - Remedial works to maintain

T5 Cypress: Fell to ground level - Poor location, outgrown space, VERY close to property (touching windows), blocking light

H6 Hedge: Reduce by approx 1m and shape all sides - routine maintenance
