Details for conditions 4 (Qualified Engineer), 6 (Design and Method statement showing works in relation to Crossrail) and 7 (Site Investigation and Remediation Scheme Submission) of planning permission ref. 2018/0575/P granted on 15/11/2018 for 'Various alterations to theatre building (Class D2) including basement extensions, creation of new entrance fronting Princes Circus, replacement of external lighting to facade and plant at roof level, installation of pavement lights and delivery hatch as well as minor alterations to facade and doors.'
