e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

South-western corner of rear garden

T1Laurel(Prunus spp)This tree is tall and thin due to its courtyard environment. It is partially blocking two windows on different floors.

Coppice to ground level (by means of sectional dismantle) to 2" above ground level. Do not poison. Let the root stock re-generate so it can be maintained as a small shrub going forward.

Courtyard

T2Magnolia (Magnolia spp) Tree canopy covers two floors. This tree has been heavily reduced in the past, just below top floor window (around 4-5m). Trunk is growing against neighbouring property wall, and the roots are displacing paving slabs.

Reduce tall single-stemmed Magnolia in height by approx. 3-4m to previous reduction points. Balance crown and prune to be as narrow as possible.
