Sycamore (T1) – Reduce crown down to 1m below the previous cuts, ensuring nothing is overhanging the roof next door, pruning back to suitable growth points. The aim is to let more light into the adjacent property, reduce residue and material drop, and restrict the root growth. The tree is close to the property behind.
