e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Side/Front Garden:

T1: Willow (TPO): Approximately 13.00m. Reduce back to previous most recent reduction points whilst preserving a suitable amount of furnishing growth to ensure crown continuity and preserve aesthetic value.

Rear Garden:

T2: Bay: Approximately 7.00-8.00m. Reduce back to previous reduction points (approximately 20-25%) in order to shape and control dimensions. Thin crown density by up to 20% to increase light levels.

T3: Magnolia: Approximately 7.00m. Thin crown density by approximately 20%. Judiciously reduce lateral and sub-lateral branches overhanging the lawn by 15-20%. Lift over path by 0.50m.

G3: Conifer Group: Approximately 6.00m. Reduce/trim lateral and sub-lateral branches by 10-15%. Reduce height by 1.00-1.50m.

G4: Group of Tibetan Cherries: Approximately 5.00m. Remove dead wood. Thin crown density by 20%. Judiciously reduce lateral branches which overhang the lawn by 15-20%. Lift over path by 0.50m.

Reasons: General maintenance unless otherwise specified.
