T4Whitebeam x 1 (Sorbus aria) To improve light in this area of the garden.

- Remove lowest small limb over hanging garden

T5Acer spp x 1To improve light to this area of the garden.
Suggested works:
- Lift by removing lowest lateral limbs
Rear garden
T6Hornbeam x 1 (Carpinus betulus) To improve light to this area of the garden.
Suggested works:
- Lift all round by 2m
