The Council has considered your application and decided to grant Listed Building Consent subject to the following condition(s):

1 The works hereby permitted shall be begun not later than the end of three years from the date of this consent.

6 Reasons for granting listed building consent: 25 Goodge Place forms part of a group of four storey stock terraced town houses with former shopfronts at ground floor (some converted), dating from 1766-67 and situated in the Charlotte Street Conservation Area. This conservation area is situated in an area known as 'Fitzrovia'. The area was developed speculatively as a primarily residential area in a relatively short space of time (1750-1770); as in many areas of Georgian London the three or four storey terraced townhouse was the favoured form. The application seeks to carry out minor refurbishment and fire safety works to the building. The majority of the works are like for like repairs or relate to modern fabric. The internal alteration to the ground floor flat entrance restores the legibility of the original floorplan and is considered acceptable.

The proposed works will not harm the special interest of the grade-II-listed building.

Public consultation was not necessary as the works requiring listed building consent relate to internal works only. The site's planning history has been taken into account in making this decision.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in general accordance with policy D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the NPPF.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2019.
