T3: Prunus (6m): Remove due to poor condition. One stem is dead and one leans heavily into neighbouring property.
T4: Oak (15m): Crown reduce by 2m as part of regular maintenance and to keep tree at a size suitable for its location
T5: Willow (6m): Fell due to close proximity to house
T8: Whitebeam (6m): Crown reduce by 1m as part of regular maintenance and to keep tree at a size suitable for its location
