Proposal:

REAR GARDEN: 1 x Sycamore (T1) - Reduce 4 longest lateral limbs that grow towards Kenview site by up to 30% or up to 3m.

2 x Sycamores (T2 & T3) - Reduce overall crown by up to 30% or 2 - 3m in line with BS3998 standards of arboriculture.

4 x Horse Chestnuts (T4 - T7) - Reduce overall crown by up to 25% or 3 - 4m generally be back to previous within BS3998 standards and remove lower lateral growth that encroaches into Kenview garden and crown lift only on Kenview side up to 4m height.
