The property is currently configured as a two bed, one bathroom flat situated on the 6th floor. The proposed extension would increase the size of the communal living space as the wall between the existing reception and main bedroom will be removed and access provided to the proposed roof extension by a new stair in the reception room. The stair will provide access to a new main bedroom on the 7th floor, with a further stair and access hatch providing access to a roof terrace above.

The proposed extension will sit adjacent to the existing 7th floor stairwell building, which provides access to the roof.

The roof extension will not be visible from Southampton Row as it sits back a considerable distance from the front facade and there is a tall decorative raised gable facade to the front.

There is an existing means of escape access route across the roof, which will be retained but raised over the new roof extension. The applicant will consult with Camden Building Control to confirm that the proposed arrangement of the attached application would meet Building Regulations requirements.
