They therefore contribute to the
Conservation
Area and are an amenity.

• Consideratio n should be given to their amenity and also their health and condition. Should Camden be mindful to accept felling, the applicant should be required to replace with suitable trees so as not to damage the Character of the Conservatio

n Area.

Assessment

The s.211 notice is for the removal of an common oak, a Chinese privet and a Cotoneaster from the rear garden of a residential property that is situated within the Fitzjohn's Netherhall Conservation Area.

All three trees are of minimal visibility from the public realm and are not considered to significantly contribute to the character and appearance of this part of the conservation area. The trees may be visible from private properties but the planning practice guidance on tree preservation orders as part of the NPPF states "The extent to which the trees or woodlands can be seen by the public will inform the authority's assessment of whether the impact on the local environment is significant".

None of the trees are of a rare species or are of any known cultural or historical significance. The trees are not considered to be noteworthy examples of their species.

The trees may provide some screening between properties but this is not considered robust enough justification for The Council to object to the works and serve a tree preservation order in line with the planning practice guidance on tree preservation orders as part of the NPPF.

Habitat provision is not considered robust enough justification for a tree preservation order to be served.

The Council does not object to the proposed works.
