Assessment

The s.211 notification is for the removal of a Magnolia tree from the front garden of a residential property that is situated within the Hampstead Conservation Area.

The tree is highly visible from the public realm and provides visual amenity to the public. The tree contributes to the streetscene, and the character and appearance of the conservation area.

Downshire Hill has many small to medium sized trees in the front gardens of residential properties which is typical of this part of the conservation area, which links in with Hampstead Heath at the NE end of Downshire Hill. This "spill over" of greenery from Hampstead Heath into front gardens is part of the character and appearance of this part of the conservation area and should be protected.

The tree appears to be in at least fair condition and have a significant safe useful life expectancy. The submission alleges that the tree is contributing to structural damage, however no details were included. The agent was contacted to provide details but a response was not received.

If the wall is to be rebuilt due to damage, it is likely there is a design and/or engineering solution that would allow for the wall to be rebuilt and the tree retained.

The application states that the tree will be replaced; however, a replacement tree cannot be secured by condition when determining a s.211 notice. As such, the proposed replacement planting is unenforceable and therefore cannot be used as justification for the works.

The objections are considered to demonstrate that there is strong local support for the retention of the tree.

It is recommended that a TPO be served to protect the amenity the tree provides and the character and appearance of the conservation area.
