e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Viburnum, 40% crown reduction, representing 2m from all branch extents, it is a fairly well consolidated shrub with previous hard pruning probable. Growth control required to control height and spread in a small courtyard.

T2 - Birch, reduce top of tree by 2m, then crown lift by 1.5m to remove obstacles to the direct sunlight coming around the base of the trunk.

T3 - Japanese maple, crown lift by 1.5m to remove obstacle branches to the direct sunlight passing beneath the crown.
