- T2- Eucalyptus. To reduce the crown of the tree by 25% (approx 3 meters) to maintain the tree within its environment.
- T3 London Plane. To reduce the lateral spread of the branches to the left of the tree by about 3 meters to elevate weight and reduce chance of failure and n the future.
