T1. False Acacia (Robinia psuedoacacia)

Front garden Semi mature co-dominant stemmed tree, previously reduced. To maintain cyclical pruning schedule; reduce height by 2m and thin canopy to improve light and form. Crown lift over footpath to statutory height (3m)

T2. Common Ash (Fraxinus excelsior)

Rear garden adjacent to house. Mature tree previously reduced. Prune off stem suckers, Reduce branch growing towards rear garden of 233 to main canopy line.

T4. Norway Maple (Acer platanoides)

Rear garden LH boundary Semi mature tree. To improve light and form reduce canopy all round by approx. 20% (2m in height and 2m in lateral spread) Reshape and balance.
