T1Scots Pine x 1 (Pinus sylvestris)This large mature tree has a heavy lean.

Suggested works:

- Thin crown on the side of the lean by 20% to lessen weight
- Remove creeper from crown
- Remove all substantial dead wood

Rear of house 2

T2Indian Bean Tree x (Catalpa bignonioides) This tree is encroaching on property.

Suggested works:

- Reduce back from the property by approx. 1m to give 2m clearance
- To balance crown, reduce over long branches by approx. 1.5m back into the main crown to balance
- Remove substantial dead wood

Rear of flat 3

T3Sweet Chestnut x 1 (Castanea sativa) This is a large veteran tree that is encroaching on terrace and property.

Suggested works:

- Selectively reduce back from property by approx. 1m to give 2m clearance
- Reduce over long branches over hanging the terrace by approx.2m back into the main crown
- Selectively lift by 1m to balance skirt
- Remove epicormic growth

Left side garden

T4Copper Beech x 1Very large mature tree.

Suggested works:

- Remove dead wood

Left side garden

T5Sweet Chestnut x 1 (Castanea sativa) Veteran pollarded tree.

Suggested works:

- Remove dead wood
- Remove basal growth

Drive way

T6Cypress x 1This tree is in a very poor condition with in which half the crown has died.

Suggested works:

- Fell to ground level by sectional takedown.

Drive way

T7Scots Pine x 1 (Pinus sylvestris)Suggested works:

- Remove dead wood

Front of flat 4+7

T8Lime x 1(Tilia spp) This tree has outgrown its location.

Suggested works:

- Reduce crown all round to previous reduction approx.2m leaving furnishing growth
- Lift to crown break
