e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Lime (T1) – Reduce crown back to previous cuts (approx. 2.5m reduction) leaving plenty of furnishing growth. (The tree is very big and blocks light to adjacent gardens. This is routine maintenance to allow more light in and maintain the current size of the tree).

Magnolia (T2) – Reduce branches growing towards the house to give 1m clearance. Reduce overlong branches to even out the crown. The tree has lots its shape a bit and this works will create a more compact rounded canopy.
