NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Bay (T2) - Reduce back to previous reduction points (approx. 20 - 25%) in order to shape and control dimensions. Thin crown density by up to 20%.

1 x Magnolia (T3) - Thin crown density by approx. 20%. Judiciously reduce lateral and sub-lateral branches overhanging the lawn by 15 - 20%. Lift over path by 0.5m.

Conifer Group (G3) - Reduce/trim lateral and sub-lateral branches by 10 - 15%. Reduce height by 1 - 1.5m.

Group of Tibetan Cherries (G4) - Thin crown density by 20%. Judiciously reduce lateral branches which overhang the lawn by 15 - 20%. Lift over path by 0.5m.

The Council has considered your notification of intended works to trees dated 30 July 2020 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these

standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
