- 1) 5 x Sycamore trees at South West end of property's garden: reduce overall crown by up to 2-3 metres on all trees (25% crown volume reduction). These trees have been reduced previously to this specification so work is ongoing management.
- 2) Large Laurel shrub in same area of garden: remove to ground level; remove all other laurel shrubs in the area.
- 3) Large Ash on boundary with Fitzroy Park: reduce overall crown by up to 2 metres (20% crown volume reduction). This tree has been reduced previously to this specification so this reduction is ongoing management.
- 4) Small Hawthorn next to Ash: remove to ground level.

All reduction work will be carried out to BS3998 standards. All cuts will be made to suitable growth points.
