e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Poplar tree at the back of the garden has one very tall slender lateral limb growing from the first lower union. This limb is disproportionate to the rest of the tree as it has grown out to chase the light. The limb moves around in the wind which is unnerving for my client. Due to the fast growing and brittle nature of this species, I believe it is in the best interests of safety to heavily reduce this limb. The limb could be removed and the tree will be proportional and balanced, however I am proposing & seeking permission to reduce the limb by 5 metres (leaving approximately 5 metres remaining) so as to not leave a wound near the trunk. I have attached several photos to this application which indicates the necessity for my proposed specification.
