The Council has considered your application and decided to grant permission subject to the following condition(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless

otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans: Submission Statement dated July 2020, Cover Letter 13/07/2020, PL-0003

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission.

The application seeks to illuminate the façade of the eastern elevation of the Eastern Coal Drops at high level, utilising lampposts on the pavement on the western side of Stable Street. Intervention to the fabric of the listed building is minimal and in accordance with the Heritage Partnership Agreement for Coal Drops Yard (ref. 2018/3650/HPA). The existing electrical supply within the lamppost columns will be utilised and would minimise additional electrical infrastructure, which is welcomed. The justification for the works is robust and it is considered overall that the lighting scheme has been designed utilising a heritage-led approach which will serve to preserve the special architectural and historic interest of the listed building and the character and appearance of the wider conservation area.

The proposed lighting would be located a sufficient distance away from any nearby residential properties to ensure no harm would be caused to neighbouring amenity in terms of increased illumination and light spill during evening hours.

No objections were received following statutory consultation. The planning history of the site and surrounding area were taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.66 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013. Special regard has also been attached to the desirability of preserving or enhancing the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposal is in general accordance with policies D1, D2 and A1 of the Camden Local Plan 2017. The proposed development also accords with the policies of the London Plan 2016 and National Planning Policy Framework 2019.
