e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 = Yew Tree = fell because of excessive shading and detrimental amenity value to the owner. Poisonous berries caused death of pet dog. Currently shaded by surrounding trees, occluded by the fence and wall boundaries and provides no public amenity. The tree is shielded beneath adjacent greater established trees and this is impacting its growth. The occupant has serious health considerations which are being compounded by the presence of the tree.

Proposal to fell and replace with 1nr. flowering Chinese dogwood to provide high amenity value. These trees shall be planted and maintained to the standards set out in BS8545:2014.

If the LPA do not consider the tree should be removed then we request consent for immediate pruning and cutting back. All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)
