- 2 Griselinia Crown Reduction - Reducing the height and spread of the tree by up to 2 metres Rounding off crown
- 3 Purple leaved plum Crown Reduction - Reducing the height and spread of the tree by up to 1 metre.
- 4 Sycamore To prune 2 lowest limbs growing over neighbouring property plus limb closest to clients property cut back to previous reduction points.
