e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Large Lombardy Poplar on rear garden border of stated address: this tree is very large and several substantial branches have broken out in the recent high winds. Surrounding houses enjoy having the tree but are worried about it's height and movement in high winds. We are proposing a 6 metre reduction in height (which is approximately 20% of overall height); shape up overall crown to bring into tidy and uniform shape (up to 2 metres in width); all cuts will be made to suitable growth points in line with BS3998 standards.
