e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Ash (T1) - reduce crown by 5m in height and 3m on lateral branches (back to previous cuts). The tree is very leggy and there is are no logical pruning points further out.

Ash (T2) - reduce crown by 3m on all aspects. The tree is has grown very leggy and is blocking light. Recently a branch snapped out. The works will reduce any likelihood of branch failure.

Birch (T3) - reduce height by 3m and shape. To restrict root growth and let more light in to the property.

Pear (T4 - In garden of 59 Camden Sq) - Prune overhanging branches back to the boundary line (up to 1.5m).
