Hi Jessica,

I have read the I Love Hampstead updates regularly since I took on this project. I think it is a great idea and respect your energy as a community leader. The proposal to buy the cottage for use as a base for the SNTs is a great example of philanthropy and is more than possible given the local wealth.

With regards to the disposal process the DfE must navigate; it is obliged to commission a property review which will conclude with a minimum value being determined by an independent body. The property then must be placed on the open market. There is usually a process for public bodies to offer up properties to each other before this but, as the Met has said it won't buy it back, it may be that the NHS or LB Camden take an interest. I suppose that will depend on their local strategy at the time. The DfE would not be in a position to offer a special price to a buyer no matter what the proposed use.

For your own knowledge the entirety of the building, including the cottage, is Sui Generis in planning terms. Having been excluded from the planning application, the cottage will remain so if we secure permission for the school (D1) and the business and enterprise suite (B1). This was done to limit the school's ability to move into the cottage but the side-effect obliges any potential developer to obtain planning permission no matter which use class they wish to secure; be it a police station, patrol base, residential or otherwise.

I hope this helps to inform your proposal.

Hi Andrew,

I send an email to about 2,000 residents in NW3 every week about "stuff" going on in Hampstead or info which may be of interest. You can see some of the stuff that I do on my facebook page called I Love Hampstead – NW3. Do see the post I will make when I send the next one out on

Sunday so you can see what is in my mind. We have discussed this before and you have suggested that the DofE may offer the cottage at a special price if it would be used for the Met. The below is the best structure I can think of given the commercial interests investors may have. Do let me know if the special price may still be on the table if this is used for the Met, but bearing in mind that people may wish to sell after a while – although I hope that I attract long term investors. But, we would want the cottage to be refurbished so that no further work needed to be done I would posit.

Conversation with Hampstead residents

I am sending this on email only and not putting on facebook as I wish to have a conversation only with residents of Hampstead and Frognal and Fitzjohns on this one. As some of you know, I have been trying for some time to achieve a base for our bobbies on the beat in our area – and specifically in the old Hampstead police station. The idea is that the Safer Neighbourhood Teams for Frognal and Fitzjohns, Hampstead Town, Belsize and Gospel Oak in the first instance would be based in the venue. It would not be a front desk operation but solely a base out of which the PCs can do their work. The options are first, if Abacus obtains planning permission to see if they can have some space for these SNTs and second to buy the cottage next to the old police station (which forms part of it) and use that for the base. I will be chatting to the school to see if space for the SNTs is achievable and workable.

I am continuing to think about what to do and wanted to float the following idea with residents to see if this has any legs so that I can pursue it further if so.

- 1. A group of residents come together to buy the cottage;
- 2. It would be using the vehicle of a private limited company with shareholdings to match contributions;
- 3. The cottage would be offered to the Met at no rent for its use. It's the only way that MOPAC may support this;
- 4. Residents would have the upside of the capital appreciation of the property over time (if any assets can go up in value as well as down so this is not without risk) but no income in the meantime;
- 5. Clearly the upkeep of the property would require funds and the property would have to be managed:
- 6. There would need to be thought to an exit for shareholders should they want it. My thoughts were that initially the property would be offered to the Met for a 5 year term and then the position reviewed after that. There would also need to be thought about what to do if a shareholder wants to exit before the 5 year term is up.

Would anyone be interested in being part of this venture? If so, could you contact me on jessicalc@lawlcs.com and let me know in the first instance whether you are interested an up for a further chat?

Having a base would not be a solution to the existing type of crime we are suffering up here. But, it would provide more eyes and ears on our streets as the PCs go to and fro the base.

That is ambitious, but we must be if we are to succeed. The school has confirmed it would be pleased to share its staff room with the Hampstead / Belsize patrol as a starting point to achieving your goal. It may well be that the relationship is positive enough to expand to include other patrols within the school curtilage in time. I expect they would want to know the expectations of area from the police for a patrol base if it were to allow for so many teams in future. I don't know how many staff this would include but that would come out in discussions.

Unfortunately there is no scope for the DfE to give up unused space to the police or any other user at nil consideration. Only the appended house at 26 Rosslyn Hill is not part of the planning application. It is expected to be used as office and welfare facilities for the contractor until the building work is complete following which we are required to dispose of it on the open market. I hope that discussions with the school are positive when you make contact.
